

User Manual for Renewing a Mining License

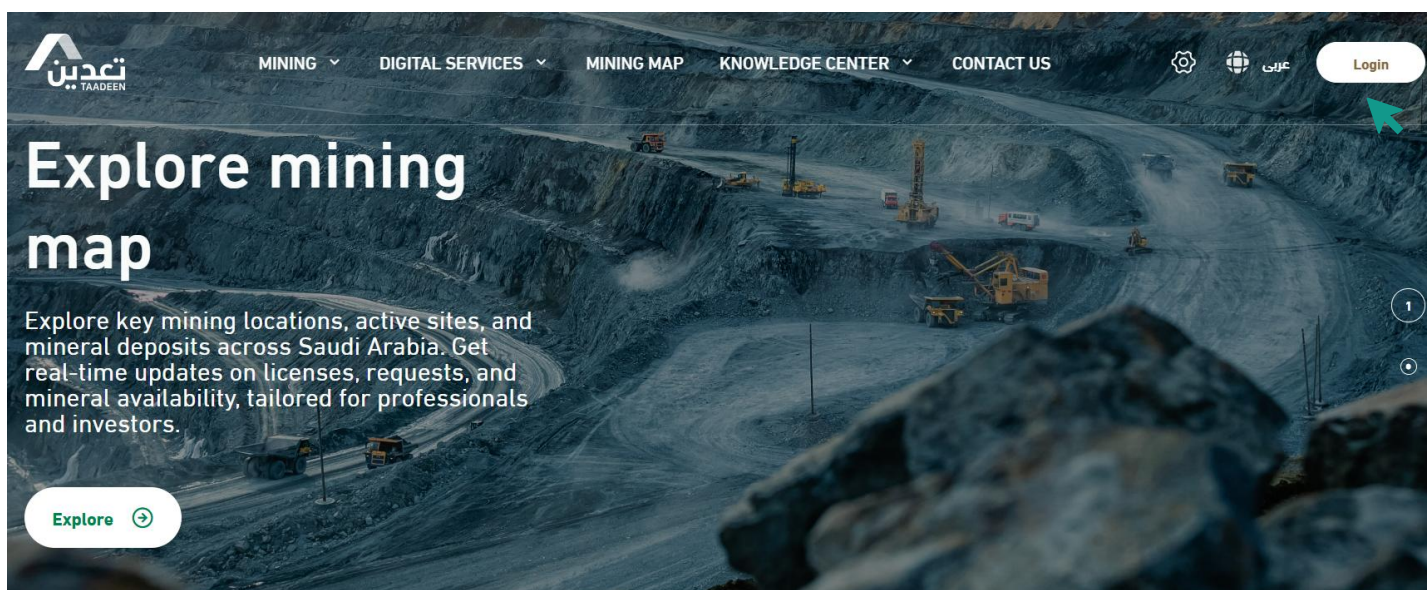


Service Description:

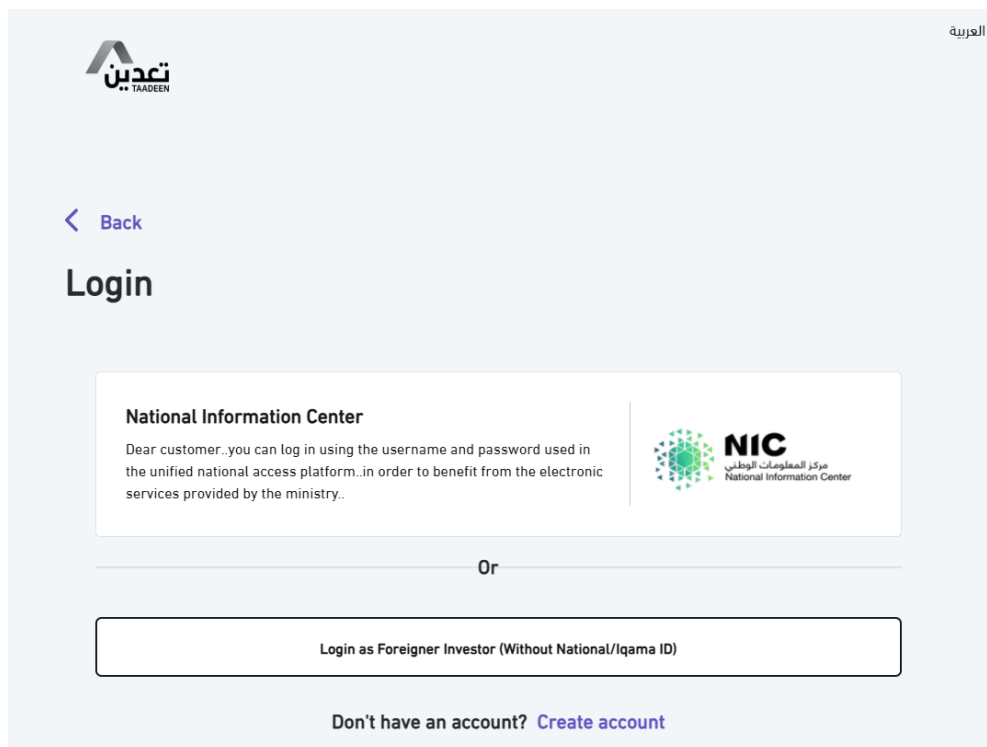
A service that enables investors to renew a license for the exploitation of Class (A) and (B) minerals.

1- Visit [Taadeen Platform](#) and click on "Login" option.

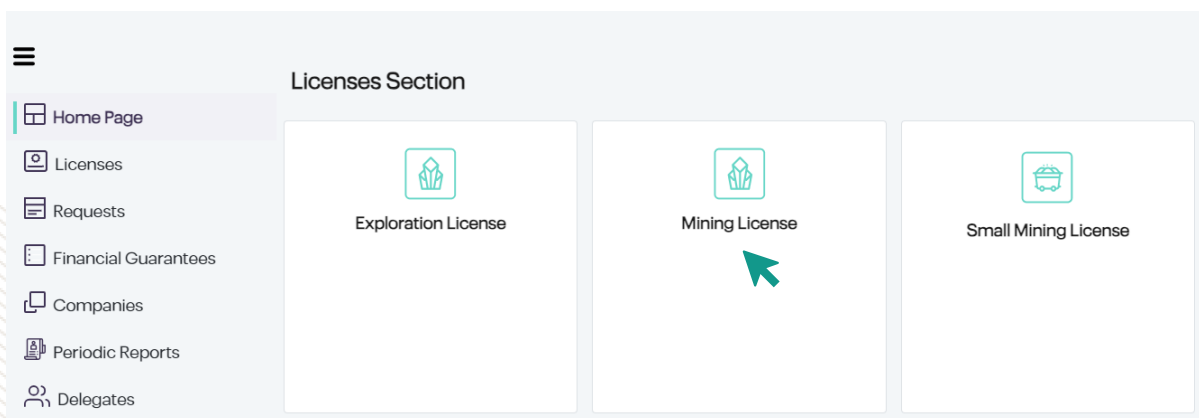


2- Log in to your account.



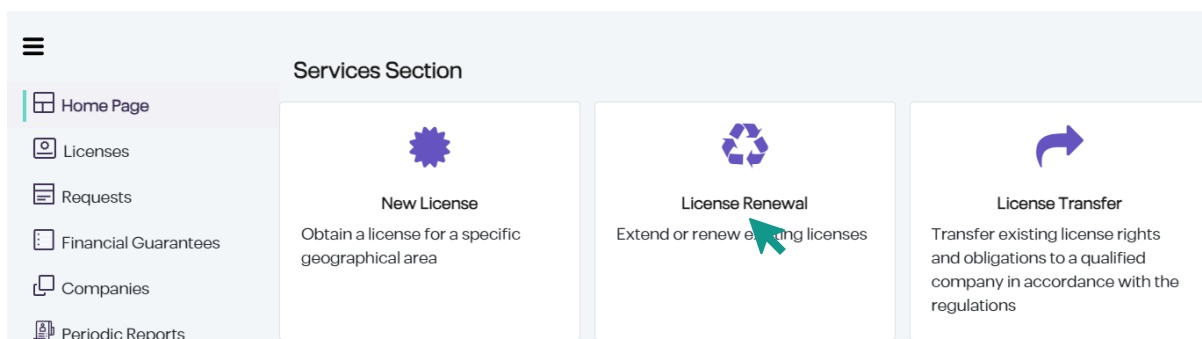

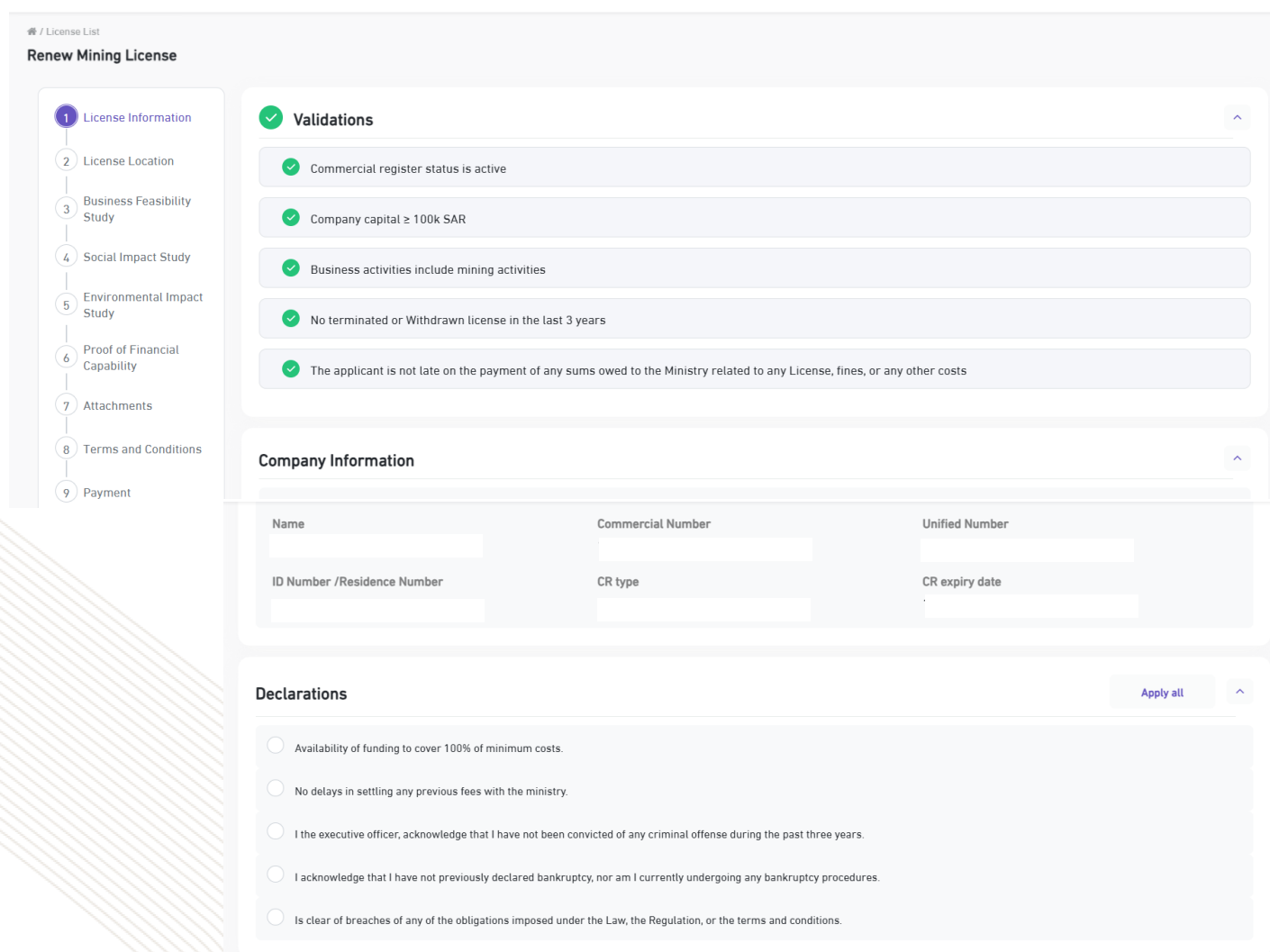

General Terms and Conditions

To Ensure that the financial guarantee remains valid throughout the license term and to renew it, as to keep it valid.

Take all necessary measures to ensure the implementation of rehabilitation and closure.

The value of the financial guarantee will cover the estimated cost of Rehabilitation and closure plan, as well as any Sudden Closure.

That the presented information regarding the costs of the rehabilitation and closure plan are correct and accurate.

That the person assigned to prepare the report on the estimated total rehabilitation and closure cost in the rehabilitation and closure plan is an independent and qualified person.

That the report of estimated total rehabilitation and closure cost complies with the minimum requirements stated in Article 85 of the Regulations.

To bear all financial consequences and compensation resulting from violating the rehabilitation and closing procedures.

Increase the amount of the financial guarantee annually if the guarantee is a partial financial guarantee.

That the Ministry has the right to request an extension or enforce of the financial guarantee in accordance with the licensee rehabilitation and closure works.

Commitment to continue conducting the necessary geotechnical studies for the mine, tailings dams, mineral ore processing facilities, and piles of rock waste within the boundaries of the license to maintain safe slopes and include them in the mining plan and annual periodic reports submitted to the Ministry.

Design the inclines and sides of the excavation engineeringly and geotechnically, ensure their safety from collapse, and stabilize them during work in the mine, after completion of the work, and upon closing the mine, and bear full responsibility for any collapses or damage to lives or properties, treat any damages resulting from any collapses, and bear the costs of repairing and rehabilitating.

Comply with the plan to regularly interact with Local Communities.

Comply with the plan that stipulates the process which shall be followed to address any complaints from Local Communities during the License period.

Without prejudice to Article (139) of the Executive Regulations of the Mining Investment law, allocating of using the exploited mineral(s) for the industrial purposes that feeding factories, whether belonging to our company or other parties, according to documents such as invoices, delivery notes and receipts, which are subject to control, and to carry out the processes of processing, converting and manufacturing the extracted minerals into a product for industrial uses to achieve value added

Commitment to the pledges submitted to the Ministry, including those which previous licenses (exploration licenses) were issued based on, which made our company eligible to apply for small mine licenses or mining licenses.

Adhering to the methodology as the Ministry prescribe for calculating quantities of minerals or ore exploited (installing a scale at the license site and operating for using in measuring the quantities of minerals or ore exploited, while maintaining the scale in operation condition, and to remain in service permanently).
