Vision 2030 : Mining sector to become **3rd pillar** of the Kingdom's national economic industries



US\$2.5 Tn of untapped mineral wealth offers significant exploration opportunities.

Robust infrastructure and skilled workforce strengthen Saudi Arabia's global mining status.



Financial incentives: Exploration Enablement Program; and Saudi Industrial Development Fund cofunding up to 75% of CAPEX

Saudi Arabia is the Largest Economy in the Middle East & Africa and is Home to One of the Fastest Growing Populations in the Region





Since launching Vision 2030 in 2016 GDP has grown ~9% annually to USD 1,108 Bn²











In Addition to a Rich Mineral Endowment that Creates an Opportunity to Unlock Processing and Become a Global Hub







Round 9: Nabitah-Duwayhi Belt











2025 Competitive Tender Rounds Timeline



 PQQ phase will be active till 14th September 2025. However, bidders who will be submitting their PQQ forms after 14th May 2025 (15 days before the commencement of online bidding for Round 9), upon qualification can only participate in Round 11.

PQQ criteria is designed based on the eligibility criteria of the mining law & regulation


